Q: I am a manager of a large corporation, and I would like to remain anonymous. This is because my question has to do with a large downsizing that will be occurring soon where I work, and if this information were to leak out too soon, I would probably have employees walking off the job, as well as bad morale for a long time to come. And while this is a situation that must happen, I still want to be able to help these employees in the transition, so they don’t have to suffer too much when they lose their jobs. Is there any advice that you can offer or resources?

A: The Sutter County One Stop does have information and resources that can assist you and your employees during the challenging transition of the layoff process. First of all, be assured that you can approach us before the layoffs are made public, and we will keep this information confidential.
